We have been fortunate and gained a couple of people, wanting to join the league, because of this, we have been able to do some restructuring, two of our longest standing fixture secretaries are being put out to pasture, Steve who has been a fixture secretary for 15 years, and Dan 12 years, I am sure you will agree, they have served Grass roots football well. They will remain as fixture consultants, if required by the officers taking over their age groups next season. A few thank you gifts., Joe who organises everything to do with the Trophy Events From U7 to U11 groups, fixtures, kick off times, etc. hours upon hours of work. 7. Book-Keeper: The accounts were done slightly early due to the book-keeper going away to celebrate her 25° wedding anniversary, and needing to get them to the accountants, there were accrued fines, league fees and invoices still outstanding. Closing balance @ 25th May 2018. £33.006.26p less 18-19 League Fees Season 17-18 minus £ 8.568.74p a difference of £4.821.94p from last season. Please note, increase in my salary additional inland revenue and pension payments @ the 2016 and 2017 AGM Potters Bar United and other Clubs made reference to the secretaries salary, as informed at the 2017 AGM a sub-committee would be formed by Ian Woods to review this. My salary was reviewed in accordance with the national minimal living wage for seasons 2017/2018 / 2018/2019 2019/2020 NO additional cost was levied on the clubs for this. a subcommittee will meet again in 2019 to review season, 2020-2021 onwards. Registration Envelopes and Result Cards larger quantities purchased as stock levels had diminished. Cup Final increase trophies for cup finals and trophy events are sale and return, however the U8 and U9 events are still to be held, so we have had to retain and pay for sufficient trophies based on maximum quantities.

Balance @ 6° June 2018 £38.197.26p accrued monies, paid in since 25° May [outstanding monies can these be sent in ASAP] I should not be chasing outstanding monies from end of April – start of May in June. The signed audited accounts have been returned from the auditors and certified that they are in accordance with the books and records of the Watford Friendly League They will be sent to the Sanctioning Authority along with the minutes of the AGM. Withdrawals of teams let Tracy know ASAP, Likewise additional team entry contact Tracy up to 30° June there will not be an issue, after this date Tracy will consult with the relevant fixture secretary who will advise if this is possible. New Teams joining the league with existing clubs coming from another league, teams moving from club to club and new clubs subject to be elected can you please provide your fixture secretary with as much information as possible about the team.

If they came from another league what league. The division they were in and where they came etc., if newly formed have the boys played football before with individual teams; this will help in getting them placed in the right division. Teams CANNOT enter outside competitions-tours-tournaments, during the playing season, unless consent is gained from the WFL Management Committee. Don't book or arrange anything, until permission has been sanctioned.

Since the AGM Enfield Borough FC have withdrawn, they also applied unbeknown to us to enter the EJS.

Substitutions in all WFL League Games - WFL Cup Games and WFL Finals

U7 U8 [5 from 5 named] the maximum total of players you can play is 10

U9 U10 [7 from 7 named] the maximum total of players you can play is 14

U11 U12 [9-A-Side] [5 from 5 named] the maximum total of players you can play is 14

U13 U14 U15 U16 U18 [5 from 5 named] the maximum total of players you can play is 16

Players @ any age group can only PLAY FOR THE TEAM THEY ARE REGISTERED TO if you want to play them in another team they need to be transferred. Transfer forms are on the WFL website. Players can only play if they have a valid ID Card. NO CARD NO PLAY.

Registrations if they are hand delivered make sure you do this at a respectful time, 8am to 8pm <u>DO NOT</u> send them registered, recorded, special delivery or by courier. Big Clubs wanting to hand deliver all their registrations please email me to arrange a suitable date and time. June – July – August and the first two weeks of September I spend 16hrs plus, 7 days a week, getting these players registered, I don't have the time to keep trekking to the sorting office. Check postage, underpaid postage gets detained. Make sure you enclose a self-stamped addressed envelope for their return.

14. Executive Secretary: Clubs Charter Status. You need to get the ball rolling this season. If it has lapsed you need to re-new it. Or in some cases start it. I have obtained a list via WGS and crossed referenced it with your forms and there are discrepancy's, which I shall once all the forms are returned take up with County. As it stands and this may not be 100% correct, and if you are listed and you have it, you need to address this with your County FA and get them to update WGS, the following clubs need to undertake this, during the course of the season. 100% Soccer, Alyth Belsize, APB FC Barnet, Arsenal Girls, Berkhamsted FC, Colney Heath, Edmonton Eagles, Go Stars, Hadley Rangers, Hampstead, Hendon United, HGS Academy, HMH, Hinton & Finchley, London Colney Youth, London Stars Premier, Mill Hill Youth, North West London Jets, Oakhill Tigers, Oakland Wolves, Olympiacos, St Gregory's United, Turnstyles, Watford Youth Sports and West Herts Youth.

Joe McGillivray is the person you need to contact if you need any help or advice on this. Joe will be reviewing this once we have an updated and correct list, and writing to clubs who need to undertake this, and also call a club charter standard meeting, packs should be available to download on your County FA website, if not, contact them and ask for one to be sent to you. fines will be issued if you have done nothing about it as previously advised. And your continued membership within the league will be reviewed. I suggest you download or request the charter standard pack from your County FA NOW, and start completing them. Once Joe has contacted you, and you are informed of the date of the meeting which will be arranged in due course, you will be required to attend the meeting, with the form, and Joe will review how far you are with it, He will also help and advice if needs be. And also monitor your progress from completing, the form and it being submitting

WGS there are clubs and Teams with pending suspensions and suspensions, relating to 2017/2018 season, please sort these out, you cannot affiliate until these cases have been closed, neither can I affiliate the League, as Clubs will be missing. Please affiliate by the 30° June latest, the League can affiliate as from 1° July, BUT to do this all Clubs and their Teams must be affiliated, to affiliate the League is massive time consuming task, each team entered into the league has to be accounted for and assigned to a division. Until I have done this the league will not be sanctioned to play. If the League is not sanctioned you cannot play. I was chasing clubs at the tail end of August last season to affiliate so as I could complete the leagues affiliation. Congratulations to Marisa, both Aldenham Excel and Edgware Town are the 1° to be county affiliated.

Discipline, Yellow Card, Red Cards, Misconduct. Are dealt with by the relevant County FA. Please inform managers – parents, players etc not to contact me to say it's unfair they disagree with the punishment, its harsh etc. it is not a matter dealt with by the league. Misconduct MUST be reported by the Clubs to the relevant County FA and it would be helpful if I was copied into it. whilst I cannot do anything about it initially, if I am aware of what is going on, I can keep records and if needs be take issues up with the Management Committee. Where stuff is now dealt with directly at County level, it by passes the league. Players with a match ban, carrying over or starting 18-19 it is down to you to send their ID card back with the dates of their match ban. I will be checking WGS before the season starts. Match bans start 7 days after a player has been sent off. If it's not showing on WGS chase it up with County.

Manager's & Secretaries handbook forms have been emailed out, they are also available on the WFL website. please make sure they are returned by their due date, which was on the covering email and also on the form.

WFL Agreement Form will go out in July and are to be returned on or before 31. August you cannot return these until you have affiliated to your respective county and have your 18-19 Affiliation Number. You can affiliate NOW online to your County FA if you have not already done so.

Pitches, and it has been said before, clubs not just in our league but also having teams playing in other leagues have more teams than pitches all using the same pitches. Obviously this effects the bigger clubs more, please TRY and help each other out with kick off time clashes. If teams agree to change a kick off time from what is published make sure all relevant league officers are informed.
